> Petitions for habeas corpus writs presented by Thomas E. Watson, of Thomson and C. E. McGregor of Warrenton, former state senator, in behalf of two prisoners confined in the Richmond county jail in Augusta, on charges of having failed to register under the selective draft law, were denied at Mt. Airy, Ga., Friday by Judge Emory Speer of the United States court for the Southern district of Georgia. Judge Speer, however, ruled that the jailor and United States deputy marshal at Augusta appear there nert Saturday and show cause why the writ should not be granted. He also directed a copy if the proceeding be served on the federal attorney for the Southern District. The petitions are based on allegations that the selective draft act is "unconstitutional and therefore void."




