Governor Robert A. Cooper has se cured an appointment to a berth on the Farm Loan Board, made vacant by the resignation of Representative Asbury F. Laver, and will resign as governor as soon as the appointment is confirmed by the senate. The resignation of Coop. er as governor will result in the elevation of Lieutenant Governor Wilson G. Harvey to the governorship until the expiration of the present term in January. The salary of a member of the Farm Loan Board is \$10,000 a year.

The dispatches of Friday carried a story of a great meteor that, shot through the skies of southern Virginia on Tuesday. The meteor was seen from Richmond, Norfolk Lawrenceville, Pettersburg, Chase City and other points. Following its disappearance there was a tremendous explosion that was heard over a distance of sixty miles or more and it is said that earth vibrations were felt over a wide area. One Chase City man informed a correspondent that the meteor fell northwest of that town and there developed a report that it made a great hole in the ground that had become a lake. Up to the present, however, newspaper correspondents have been unable to locate the spot. The fact of the ball of fire trailed by a long streak of light is unquestionable; but much of the balance of the story is questionable.


