

AN ORDINANCE

An Ordinance to Prohibit Anyone Driving a Motor Vehicle Within the City Limits of the City of Camden, Without Having a Driver's License Issued by the State Highway Department:

SECTION 1 Be it ordained by the City Council of the City of Camden, Camden, South Carolina, that it shall be unlawful for any person to drive a motor vehicle along, or on, any of the streets of the City of Camden, State of South Carolina.


