Florence, Dec. 3.—The final session of the Methodist conference was opened with devotional exercises conducted by Peter Stokes, assisted by M. C. Tucker, of Brazil. Bishop Atkins gave Dr. Tucker an opportunity to render a brief account of his service with the American Bible society.

Watson B. Duncan presented resolations of thanks and appreciation for the unstinted hospitality of the people of Florence and for all the courtesies shown to the conference, these were unanimously adopted by a rising vote.


