

THE QUINCY  
HON. CHAS. S. MCALL

The Hon. C. S. McCall died suddenly after a brief illness on the morning of the 31st day of December, 1904. Notice was immediately telegraphed to the Lieut-Governor, Hon. John T. Sloan, and he telegraphed his personal sympathy and stated that he had appointed five senators to attend the funeral.

Monday, the 2d day of January, 1905, at 11 o'clock was appointed for the funeral, and the body lay in the parlors of the residence of the deceased Saturday, Sunday and until Monday morning 11, and people flocked in great numbers to view the remains. As soon as the death was announced every shop and place of business in the town spontaneously closed and people stood in knots on the street corners and talked of the dreadful calamity. Large numbers of colored people sought to get a last look at their deceased friend. Floral offerings came in profusion, made of the most beautiful flowers in artistic designs. Telegrams came from many private and official sources expressing sympathy for the family of the deceased and the citizens of the county. The days were clear and pleasant, giving an opportunity to show their respect and love for the deceased.

Monday morning was somewhat cloudy but the crowds began to gather in town and visit the tomb in which the body was to rest at an early hour, and before the cortege left the residence, the streets were lined with a vast concourse of people from all sections of the county and adjoining towns. Vehicles were everywhere to be seen in unusually large numbers, and thousands of people were present to testify to their love and respect for the deceased. They passed in a stream into the residence and viewed the remains, slowly passing out as if reluctant to leave. The Masons were present in unusually large numbers to take charge of the remains and bury them according to the rites of the order.

The active pall bearers were: C. E. Exum, P. B. Moore, T. C. Hamer, P. A. Hodges, C. S. Chaffin, H. L. McColl, J. B. Green and D. Jennings. The honorary pall bearers were: J. H. Hudson, D. D. Marshall, Sr., P. L. Drake, C. M. Weather, Edward McVey, J. Q. Marshall, J. N. Drake and Judge Ernest Gary, T. G. Matheson and J. W. Smith.

The casket in which the body was placed was a beautiful metallic and hand-made one. The funeral procession was nearly a mile long and the most impressive ever witnessed in the cemetery in East Bennettsville, which the deceased had recently dedicated as an extension of the Oak Ridge Cemetery requesting that his remains should be buried on the highest point in it. Little, however, did he think that he would be the first to be buried in it. The tomb was built of brick and cement and lined with white marble. It was the prettiest and most substantial that we have ever seen.

The chief of police mounted on a handsome iron grey horse had to go in front of the procession to keep the way clear for the cortege, as the people gathered so thickly about the way as to impede its progress.

No man has ever had such a funeral in this section of country and few greater in any other. Judge Hudson delivered the eulogy, and Dr. Bunyan McLeod, of the Presbyterian church performed the obsequies according to the ceremonies of that church, after which the masons recited their beautiful ritual, and performed the solemn rites of their mysterious craft. The songs were sung, the prayers were said, and the body laid to rest to await the resurrection morn.

A friend has handed us the following memoir:

On the 8th September 1843 in the village of Ohio in Marlboro County this distinguished citizen first saw the light. He was the oldest child of John L. McCall and Nancy Sinclair McCall whose parents came from Ireland in the early portion of the last century. To John and Nancy were born five sons and five daughters, one of the latter having died in infancy and two of the sons and the father having predeceased our subject.

The father was noted for his sterling integrity and refinement, and his mother for her large endowment with the qualities of mind and heart that pertains to the Scotch people. She still survives at the age of 81 years and is unsurpassed in an indomitable will and energy.

Charles Spencer, for such was our subject's given name, received his education principally at the Ohio Academy, and was perhaps a pupil in one of the country schools not far away. In and around Ohio was the scene of his boyhood. Farm work and the pastimes incident to farm life being the routine for his development. His father was fond of reading and kept a large stock of books on the shelves, and read such books as he could come by. Among others he was very fond of the works of the Rev. Thomas Dick, the old Scotch minister of Dundee, and this fondness led him to adopt this name for his second son who now survives near Bennettsville. His father's motto was "pay as you go, and if you can't pay don't go", and he acted it throughout his life, being scrupulously exact in all his dealings and paying cash for everything he bought. He was industrious to a great degree and delighted to work with his own hands as long as he lived.

The war for Southern Independence found Charles, as will be seen, a youth of 18 years. He enlisted in 1862 in Capt. Peterkin's company in the 20th S. C. Volunteers, and in 1864 was transferred to the Hampton Legion with which he remained till the surrender at Appomattox. He was captured by the Federals a few days before the surrender, but succeeded in making his escape and getting back to his command before it

surrendered. His courage was tested on many a hard fought battle field and he was always found in the thickest of the fight, and among the foremost on duty. He had a strong frame, though of small stature, and a will and self-reliance that would have done credit to Napoleon.

As soon as business opened here after the close of the war he obtained a clerkship in the store of Mr. William Murchison, who was reared in the same neighborhood that he was, but was many years his senior. He remained there till 1869 when with his parents he removed to Bennettsville where he opened a store on his own account on the corner where his own establishment afterward took shape about 12 or 13 years ago. His devotion to the business of his employer and his scrupulous honesty won him the admiration of Mr. Murchison and the best of a friendship that ended only with death. Mr. Murchison gave him a written recommendation which still hangs in his office as a testimonial to the high opinion of the good opinion of that fine business man, and as a memento of their friendly relationship. Murchison also invited him to call on him for aid and was half devoted several years afterwards because of the invitation and had been strictly staying in his store night and day watching every detail till in seven years it had become one of the largest in the county. He never wasted time in idle gossip or in the needless or unproductive indulgence in worldly pleasures. These things never seemed to have any hold upon him. He enjoyed society when thrown with it, but was never a seeker after it. He had many friends, many were true and tried friends. He was always ready to help a friend when once acquired. If his friend forfeited his right to the good opinion of others it never seemed to affect his friendship. This man may be said to have lived the whole period of his manhood life.

In 1870 when the Republican government of South Carolina had become a stretch in the nostrils of civilized people, intolerable to the white people, and they had determined to cast it off, the selection of leaders was of the most important consideration. In looking for a leader in this county there was one man who stood in the position, it was thought best to select him, to select him, and he was given the place of the County Chairman of the Democratic party. He proceeded in a business way, without guile or guile, and without diplomacy or promises, infused into the organization an esprit de corps that was most remarkable. While it is true that the spirit of triumph was in the air, yet the most skillful management had to be exercised to keep the party control that spirit and utilize its energy for the success of the Democrats and the good of the country, and he took hold of it with the skill of an engineer at the helm, and let on and off the pressure to suit the exact needs of the occasion and to the astuteness of the most ardent democrats rolled up a majority of 400 for Hampton, although he had had Marlboro County run down in the republican column, making allowance for the great odds with which he contended. He justly estimated the force of the enemy and then planned for their defeat. This is one of the most important points in military strategy and was employed by him in politics with complete success. He was chosen State Senator in 1877, and filled the unexpired term from which his republican predecessor had resigned. He received the nomination of the democratic party and was elected to the same position for the next session.

From 1880 to 1888 he had a long and successful career in the State Senate, and in 1888 he was elected to the office of State Auditor.
