The State levy for next year is 51 mills, including the constitutional 2 mill tax it is 71 mills. State and County, we believe, amounts to 10% in taxation, but when the legislators get to Columbia and consider the various necessities of the Government they find the scheme impracticable. It is easy to excite dissatisfaction among the people, but it is more difficult to give a reasonable excuse for it. This legislature made cessarily make the levy to suit the exigencies of the treasury.

The so-called prohibition bill passed and was approved by the Governor. It goes into effect July 1st, 1893. It does not pretend to prohibit, but to regulate and restrict the sale of intoxicants. In our opinion Horry County is concerned. it is a piece of very crude legislation and contains provisions that will be difficult of execution.






