tion and, so far as I can learn, the Legislature has not corrected the Boards action in this matter.

There was no money in the Treasury of Horry County to pay liquor constables and no provisions to put any there for that purpose. So. they must be paid out of some other fund; and it looks very much as if the Kingston Lake Bridge, the repairs on which have been ordered stopped by the Commissioners over the protest of the Supervisor, or maybe, the Sardy Bluff Bridge, about which the Supervisor has been severely arraigned, have been

Certainly, something has suffered to the amount of Six Hundred and Fifty Dollars.

The laws of South Carolina prohibits the expenditure of funds arising from current taxes for the payment of indebtedness of any previous years, and also forbids the Supervisor to draw checks unless funds have been reported in the County Treasury to pay them, and forbids payment of enecks drawn in violation of its provisions.

There are other laws besides the Cary-Cothran Act governing the methods and results of spending the people's money. Their protection against the useless waste of negligent officers has been ignored by our county Commissioners. We cannot afford to be governed by the in the forenoon, to show cause, if any Cary-Cothran Act alone. It is too expensive as applied by our Commissioners. If they know no other law governing a whiskey constables claim, they should study up or resign before they throw to the birds some more noney we sorely need for roads and bridges.

It is only just for me to add that the Supervisor has consistently protested against the payment of these Mishoe Detective claims in the form and manner in which they have been presented to the Board. Van Norton.






