Pete Hamilton, a bad negro about 21 years old, was arrested in Easley Monday morning charged with attempted assault upon a prominent young white lady in a boarding house at Easley about midnight Saturday night. Sheriff Roark carried the prisoner to the state penitentiary at Columbia for safekeeping.

Between 11 and 12 o'clock Saturday night a negro man entered thru a win dow into the sleeping room of two young ladies in Easley while they were sleeping. He attempted to choke one of them, but she managed to scream, awaking others in the house. The other young lady came to her roommate's assistance and the negro jumped thru the window and ran. His evident purpose was not accomplished. He succeeded, however, in making his getaway and eluded the search of citizens and officers who looked for him the balance of the night and most of Sunday.

The Easley correspondent of the Greenville News says the facts in the case are as follows:

"In making his escape from the residence Saturday night the fleeing person was seen to fall over a large log on the edge of the sidewalk. Here he also lost one of his shoes, which was found by one of the officers working on the case. Hamilton is an employe of the oil mill, and this shoe which was found had cot-corn and fodder. ton seed hulls in it. The make of the shoe was a Crossett and was identified as one which had been purchased by Hamilton about a month ago. Hamilton had a sore on his foot and this shoe which was found had a hole split in it, and this cutout place exactly fitted over the sore. Hamilton failed to appear at the oil mill Monday morning and sent word that he had the mumps. The ofncers, in view of all other circumstances. carried a physician to Hamilton's house, where an examination disclosed the fact that he had no mumps, but that his knees were freshly skinned and badly swollen. Minor scratches were also found on his face."

The citizens of Easley were greatly enraged over the affair and a lynching was feared, but Governor Manning was called over the phone and promised a special term of court to try the negro. in the meantime the sheriff had slipped the negro away to Anderson from where he took him to Columbia

It is reported that a negro girl was heard to make some slighting remark about the young white lady who was attacked and that the negro girl and all her people were given a short time to eave town or suffer the consequences.
