INCOME TAX NOTICE.

Columbia, March 13, 1915.

Mr. J. W. Thompson, County Auditor, Laurens, S. C.

The State Tax Commission of the State of South Carolina has sent me the following communication relative to the enforcement of the Income Tax

"The time for making returns under the income tax law of this state expired on the 20th of February last, and a very large number of persons liable to the payment of the tax omitted to make such returns within the time

"The neglect to make the returns in time hay have been caused in part by an arroncou- impression that the returns and payment of the income tax to the Folleral Government relieved these tax payers from paying the in-come tax imposed be to laws of this

"The failure to make returns with-in time have been so general and widespread that we think further opportunity should be allowed such persons to make these returns before the penalties provided by law are imposed

upon them." In order, therefore, to save such persons who will now come forward and make the proper returns, I, Carlton W. Sawyer, under, and by virtue of power conferred upon the Comptroller General, with the approval of the Gov-ernor, in Section 767 of Volume 1, Code of Laws of South Carolina, 1912, do hereby etxend the time for the making of returns and assessment of in-

come taxes without penalty until the first day of July, A. D. 1915. You will govern yourself accordingly,
