"All these were placed in my safe and held subject to further orders" continued the secretary, adding that they had been examined by no one except himself and his secretary.

Asked whether there was any possibility that copies had been obtained from the state department he replied:

"Positively no chance whatever." Senator Hitchcock presented to the committee the cablegram from President Wilson in which the latter commended the Nebraska senator for introducing the investigation resolution and expressed a hope that the inquiry would be "most thoroughly prosecuted." The message dated June 7, did not refer to the senate resolution asking for the treaty text and at the White House Secretary Tumulty said he thought it probable this request had not reached Mr. Wilson when he cabled.
