Miss Mollie Green Saved Her Scholars from Hydrophobia and is Uninjured.

NASHVILLE Tenn., April 26.—Miss Mollie Green is a heroine in Perry County, Tenn., to-night. Miss Mollie, who is 18 years old, teaches school on Cypress Creek, in Perry County, though her father, Robert Green, lives across the Tennessee River, in Hickman County. The little log school house was quiet and the little children busy with their lessons to-day when a shaggy dog, foaming at the mouth, snapoing and biting, dashed in at the door and sprang towards one of the children. The brave teacher thought only of the children in her care and sprang between them and the intruder. She told them it was a mad dog and kicked at it, her skirts protecting her.
