A SHOCKING ACCIDENT.

Mrs. Visasnka, of Abbeville, is Killed by Fall from a Buggy Near Greenwood.

[Special to the World.] GREENWOOD, Nov. 4.-This community was shocked to-day by the news of the violent death of Mrs. G. A. Visanska, of Abbeville. Mrs. Visanska was the mother of Mrs. P. Rosenberg, of Abbeville, and sister of Mrs. A. Rosenberg, of this city. Her husband is a member of the firm of P. Rosenberg, &

During the prevalence of diphtheria in Abbeville she sent her children to Mrs. Rosenberg, in this city, and this morning she started to visit them, in company with her son Julius, in a buggy. They had to cross Morton's bridge, which is about twelve feet high. During the September freshet both approaches were washed away, and the repairs have not been completed. The planks are loose and no balustrade has been put up. When they reached this bridge the horse did not want to cross, and Julius got out to lead him, leaving his mother in the buggy. When at a point near the water's edge the horse became unmanageable and backed off, pulling young Visanska after him. Mrs. Visanska fell on her head, striking against a heavy piece of timber, breaking her neck and causing instant

A RIOT NEAR ANDERSON.

Armed Negroes Fire Into White Men Starr Station-Story of the Affair.

[Special to the work.] ANDERSON, November 4.-Seven negroes, Peter Hall and five of his sons, and John Sadler, were put in jail here to-day charged with riot, assault with intent to kill, etc. The difficulty occurred at Starr Station, on the Savannah Valley Railroad, about ten miles from Anderson, yesterday afternoon.

The Farmers' Alliance and Masons held their meeting there yesterday, and there were a goodly number of white men present. A white man named Bowie got in a row over an old feud with a negro named Hall. Three of the Halls got hold of Bowie, and he was the first figure in the secession has a majority of 2,500 against 140 two fired, missing them. The negroes then opened fire on every white man that made his appearance. They emptied their pistols and fell back to where they had their guns in hiding. Then they returned and opened fire on the white men, who had to get behind a wagon body to save themselves. The wagon body was literally filled with bullets. The negroes then returned across the railroad, reloaded, and defied the white

men, daring them to cross the railroad. When the firing first commenced, Mr. J. C. Hamlin, with whom most of the negroes lived, stepped out of a store, when three of them deliberately fired

on him with pistols. The negroes were arrested at the house of Peter Hall. Early this morning Trial Justice Bryan went to the his face. He then called up some thirty Ben Robinson, also colored. Mr. Poore special constables and again asked them to surrender, which they refused to do. The men outside could hear some of the negroes scuffling with others to prevent them from opening fire on the trial justice and his constables. Fire was applied to the house, and they surrendered, but even then refused until certain officers promised them that no harm should be done them, and the

law should take its course. Ten negroes, five shotguns, one mus ket and one pistol were found in the house. Some of the guns were cocked when turned over to the officers. The negroes slept on their arms all night. One white man was shot in the leg, one negro was shot in the leg and another injured by being struck on the head with a rock. The negroes fired more than thirty shots, and it is a

miracle that no one was killed. The train left there as the fight was going on. The engineer reports that after leaving Starr he saw other negroes running towards the fight armed, which shows they were anticipating a fight.
