Rev. Mr. Schaeffer at Luther Chapel—His Third Anniversary Year, and the Life of St. Paul.

On last Sunday morning Rev. Mr. Schaeffer, of Luther Chapel, made a review of his pastoral work of that charge for the year just closed, being the third anniversary of his coming to Newberry. The review was unique. The thoughts of the speaker presented a picture to the mind's eye of the hearer.

The ministerial work of a devoted pastor, the bright foreground and far-away perspective, with its softening lines, declining light and faintly-sounding bells. Here, the baptismal font, and there the type of a scene once celebrated in Eden and ratified at Calvary and again confirmed with the roseate hues of another spring-time, and yonder the darkling fringe as the shadowy form of the reaper passes to the silent vale.

Of the flight of time as upon "slippers of list," bearing all things temporal to decay, dissolution, oblivion; but the sermons, Sunday after Sunday,—what of them, as they came freighted with spiritual truth, and laden with the words of "admonition, reproof, warning and rebuke." At the close of his sermon, which showed a prosperous condition of the church, Mr. Schaeffer, in the presence of the congregation, remarking that while in the providence of God he felt called upon to minister in holy things, he was but human and needed the prayers and sympathy of the church in his work.

At night he began a series of sermons on the Scenes in the Life of St. Paul.—the opening discourse being upon the childhood of the great apostle to the Gentiles.

Mr. Schaeffer took his text from the 11th verse of Paul's matchless exordium on charity—the 13th chapter of first Corinthians. He regretted that there is so little biography of children in the Bible, and that the few instances of childhood history, the great life-work of these colossal characters overshadowed all else; but little is related of themselves, and from the meagre text and scattered references he gathered much by inference and implication, and we prayerfully read between the lines.

Even the life of our Lord is veiled; but little is known of his childhood beyond his lowly birth, the flight and subsequent marvelous display of wisdom in the temple.

Paul was not born full-grown—he had an infancy and cooed and laughed as the dimpled babe, and grew to be a rollicking boy, brave and buoyant boy—every what a boy.

We find him a busy little Jew, greedily devouring the rich intellectual feast prepared for him by the learned Gamaliel. He was full of the fire of fanaticism. As a Jew, he was the strictest of the Pharisees; as a Roman, according to the law, he demanded his rights in the franchise. He did nothing by halves.

As a Christian, he despised Christianity, and pursued and persecuted its followers with an untiring and relentless hatred, thinking he was doing God's service. Hence it is easy to conceive that when converted to the fanatic gave place to the aroused, ever-active, zealous and enthusiastic Christian.

But Paul had a childhood, and never forgot it. He bridged the space between the adolescence of the child and the ripening years of his manhood. And we must infer, continued Mr. Schaeffer, that, as the apostle "put away childish things," he reverted often and tenderly to his younger days. He did not forget that he was a boy as many of us may sometimes do, and these reflections brought him very near the great, loving soul of the Master, who had all along so large and warm a place in his heart for little children. Annals of Newberry. THIS VALUABLE WORK IS now going through the press, and will be ready for subscribers in November. Besides the original Annals of Judge O'Neill, this book will contain the names of all the volunteers who went from Newberry District to the war with Mexico; it will contain the names of all from the County who were in the Confederate service in any capacity—that is, all whose names the compiler has been able to procure. With the exception of what happened to the County, it will contain an account of the heroic death of Calvin Crozier, who died that another night; it will contain a sketch of the trying times of the Reconstruction.

It will contain some Revolutionary anecdotes and scraps of history, not usually published in the histories of the State, or of the United States. It will tell of the early days of the County. It will contain sketches of different sections of the county, of the schools, of the celebrated Mount Bethel Academy, of the religious denominations, of benevolent societies, of Miss Galloway and her journey to Egypt, of changes in business and business firms, of descendants of families who long ago left this county.

It will contain some account of War Times in Newberry during the late war between the States. Nor is the literature of the country forgotten, but specimens of that will be given; the history of the newspapers will be related. Some account of the county, as seen through the eyes of old men, will be given.

It has been the aim of the compiler to make a book, valuable not only for the present time, but for generations to come—a standard work of reference in the history of Newberry County.
