We are not advising the violation of the law. We believe in respecting all law, but when a law has to be enforced by such a system, it is a poor recommendation for the law to say the least.

"Governor Tillman has violated the law and is liable to impeachment. The Legislature appropriated nothing for the use of the Dispensary. The Governor has contracted debts in the name of the State to the amount of more than \$300,000. The power of appropriating money rests in the legislative, and not the executive branch of the government."-Spartanburg Herald. EIGHT CENTS AN HOUR.

> The catalogue says: "These expenses may be reduced by labor. board of trustees have decided to pay not more than 8 cents per hour for work that is not educational. By this is meant that a boy who works in the mechanical department and spoils lumher and consumes time is not to be paid for his work, because it is educational. Whenever the work is of advantage to the College as well as to the student it will be paid for at the rate of "not more than eight cents an hour." The course provides two hours work per day; that would be 16 cents per day, or 96 cents per week, or not enough to pay the board bill, or with three hours work per day, with no allowance for interference through weather or otherwise, the board bill would just be paid. The trustees do not want the boys to devote their entire time to work in the fields, and all of it will not be for the benefit of the College, and a maximum price cannot be paid. There is no use to go to Clemson expecting to work your way all the way through. It is really touching to see how very many young men there are who want to go to lemson and have not the means. Very, very many of them are there now at a great sacrifice to their families and after experiencing untold trial and self-denial themselves.


