

ADVICE FOR SOUTHERN PEOPLE.

The Southern Wemen's Historical Society Resolved that the Policy of Silence Under Abuse Should Be Abandoned -The Rev. Dr. Cave Says the South Was Right-Gen. Rosser Predicts Another Invasion.

[New York Sun.] Gen. Thomas L. Rosser, in a speech made at Richmond, Va., on Decora-tion Day, when the monument to Confederate soldiers and sailors was dedicated, attacked the pension system in these words: "The men who overran us remind

me of the locusts which are now infesting portions of this State. They couldn't whip us, but they devoured our sub-stance. The army that devoured us was an army of substitutes. We killed all the substitutes. The men whom they represented stayed at home and made money and now draw pensions. "I despise the man who gives United States money to a pensioner. This country cannot stand when it makes one citizen support another. I shall never vote for a Congressman who is in favor of Government pensions." After some talk about the G. A. R. he concluded by saying:

"Some time ago we unveiled a monument to the greatest General who ever lived. To-day we unveil a monument to the greatest private soldiers who ever lived, and in time we will unveil a monument to the President of the Confederacy. But we are mocked at the North and will live to see the Yaukee army march again through the South and pull down our monuments. I don't know what sort of stuff the rising generation is made of, but if you and I are living there'll be bloodshed when that is done."

Gen. Rosser's speech was delivered at the cavalry parade. At the dedication of the monument the Rev. R. C. Cave of Richmond had his innings. These are some of the things he said, and the reports of his speech are interspersed with bracketed applause, which is said to have grown more enthusiastic at the

"I am not one of those who, clinging to the old superstition that the will of heaven is revealed in the immediate results of trial by combat, fancy that right must always be on the side of might, and speak of Appomattox as a judgment of God. I do not forget that a Suvaroff triumphed and a Kosciusko fell; that a Nero wielded the sceptre of empire and a Paul was beheaded; that beying his orders during the dispensary a Herod was crowned and a Christ crucified; and instead of accepting the defeat of the South as a divine rerdict against her, I regard it as but another instance of 'Truth on the scaffold and Wrong on the throne.'

"Appomattox was a triumph of the physically stronger in a conflict between the representatives of two essentially different civilizations and antagonistic ideas of government.

"On one side in that conflict was the South, led by cavaliers, who, with all their faults, had inherited from a long line of ancestors a manly contempt for moral littleness, a high sense of honor, a lofty regard for plighted faith, a Gordon Volunteers, of Hampton, are strong tendency to conservatism, a profound respect for law and order, and an their refusal to obey was on account of unfaltering loyalty to constitutional governments.

In truth's clear, far off light-"That the South was in the right; that her cause was just; that the men who took up arms in her defence were patriots who had even better reason fo what they did than had the men who fought at Concord, Lexington, and Bunker Hill, and that her coercion, whatever good may have resulted or may bereafter result from it, was an ou:rage on liberty."

These two speeches, as well as one made by Col. Wells Blodgett at the tomb of Gen. John McNeil, came up for discussion last Friday before a meeting of the Southern Women's Historical Society in St. Louis. Gen. McNeil ordered the arrest and execution of ten citizens of Palmyra, Mo., who sympathized with the Confederacy. This was done, according to the Confederates, because the Confederate Gen. Porter refused to release a prisoner who had been captured by guerrillas. Gen. McNeil, they say, declared that he acted under orders from Gens. Halleck and Schofield, but the act made him lose prestige among the Union soldiers and the tonfederates called him "the outcher of Palmyra."

believed in the policy of silence-why keep alive painful memories? Mrs. Meriwether said the policy of silence might do very well if the other side would keep it. As long as such speeches as Col. Blodgett's are made over the graves of such men as McNeil, she said it was the sacred duty of Southern men and women by every means in their power, to promulgate the real facts of the war between the North and the South; its real cause; its conduct; its results, direct and indirect. There is too much ignorance on these points. The conquering party all along has distorted some things, coucealed others, and misstated many events. Southern people have been so ong slandered and maligned that the whole Northern heart is hardened to them. Had the innocent men McNeil butchered been any other than Southern men, had they been ten innocent negroes, or Irish, or heathen Chines, even at this late day shudders of borror would creep over every human at the mention of McNeil's name. But simply and solely because these ten men were Southern, their murder is approved; a costly monument is erected to the butcher's memory, and over his grave the boast is made that Lincoln promoted him for his bloody deeds. 



