# Your Social Security

"Medicare does not pay for routine nursing home care," H. M. Spiller, field representative explains.

Only limited coverage for full time skilled nursing care and other health services provided in the nursing home can be paid for under Medicare. Many people believe that Medicare pays up to a hundred days of nursing home services under any circumstances. This is not true.

Congress made it very clear that only a certain kind of nursing home care would be paid for under Medicare. This is the type in which the patient's condition, upon discharge from a hospital, requires him to be in an institution for the primary purpose of receiving continuous skilled nursing services.

Actually, a nursing home that qualifies to give this service is called an "Extended Care Facility". Services in such a facility are really an extension of the kind of service he was receiving in the hospital for his injury or illness.

The Social Security Administration is now working with its insurance intermediaries to examine more closely Medicare claims for after-hospital nursing home care.

"Many of these claims may be denied," Mr. Spiller indicates "It is important that elderly people and their families understand how this part of the law works".
