Your Social Security

The year 1969 is rapidly drawing to a close and the New Year will soon be upon us. Also upon us will be installment payments to be made on our Christmas bills, New Year resolutions to be observed or broken and income tax reports to be prepared.

H. M. Spiller of the Greenwood Social Security Office suggests that now is not too early to start thinking about these tax returns. Tax forms which are properly filed and correctly completed help both you and the social security office. This is especially true for the self-employed person. The self-employed individual gets social security credits based on the net profit from his business. A net profit of \$400 or more can get you four quarters of credit for 1969. No tax return, or a net profit of less than \$400 will result in no social security credits for 1969. You should carefully check all of your income and expense items, file your returns accurately and on time, and in that way you will be sure of receiving your proper social security edits.

Mr. Spiller also said that some people fail to show their social security numbers on their tax returns or sometimes the wrong social security number is shown. This can cause a delay in giving you your credits. Be sure that you enter your social security number correctly and in all of the spaces provided on your report forms.

NOTICE IS HEREBY GIVEN that in pursuance of a Resolution adopted by the County Board of Education, constituting ex officio the Board of Trustees of The School District of Newberry County, the State of South Carolina, and the "School Bond Act", codified as Sections 21-971 to 21-990, inclusive, Code

of Laws of South Carolina, 1962, a Special Election will be held in The School District of Newberry County, the State of South Carolina, on Tuesday, November 18, 1969. The purpose of said election is to determine whether the approval of the qualified electors of said School District shall be given to the issuance of not exceeding Three Million Nine Hundred Thousand Dollars (\$3,900,000) of general obligation bonds of said School District, whose proceeds shall be expended for the purpose of school building construction and renovation in the District, which shall consist of the following:

Construct new high school (to include vocational facilities near the City of Newberry to serve all high school students in the Newberry attendance area.

Construct six classrooms and add dressing room facilities at Mid-Carolina High School to accommodate all high school pupils from the Mid-Carolina attendance area

Construct new elementary school (kindergarten through grade four) at Whitmire, S. C.

Construct middle school (grades 5-8 near Mid Carolina High School to serve pupils in Mid-Carolina attendance area

Construct seven classrooms and a cafeteria at Silverstreet Elementary School for students in kindergarten through grade 4

Renovate Whitmire High School

Renovate the present Carver Elementary School, Rueben Elementary, Gallman High and Newberry High Schools to serve as middle schools (grades 5-8).

Renovate Prosperity Elementary, Rikard Elementary, Pomaria Elementary and Little Mountain Elementary to serve grades kindergarten through grade 4

The question which will appear on the ballots to be used in said Special Election will be:

"Shall the County Board of Education, constituting ex officio the Board of Trustees of The School District of Newberry County, the State of South Carolina, be empowered to issue and sell either as a single issue, or from time to time as several separate issues, general obligation bonds of said School District in the principal amount of not exceeding \$3,900,000, whose proceeds shall be expended for constructing and equipping new public school buildings, acquiring sites therefor, and renovating certain existing public school facilities in the School District?"

Qualifications for Voting

1. Each person offering to vote must have resided in the State of South Carolina for one year, in Newberry County for six months, and in the polling precinct in which the elector offers to vote for three months, all prior to November 18, 1969; PROVIDED, that ministers in charge of an organized church and teachers of public schools and the spouse of any such person shall be entitled to vote after six months' residence in South Carolina if otherwise qualified.

2. Each person offering to vote must have been duly registered on the County Books of Registration for Newberry County in the Precinct at which he offers to vote, on or before October 18, 1969, for the current decennial (10-year) period, and must present his registration certificate.

NOTICE TO MANAGERS OF SPECIAL ELECTION:

The Managers named in the Notice of Special Election have the power to fill a vacancy, and if none of the Managers attends, the citizens can appoint from among the qualified voters, the Managers, who after being duly sworn, can conduct the election.

At the close of the election, the Managers and Clerks must proceed publicly to open the ballot box and count the ballots therein, and continue without adjournment until the same is completed, and make a statement of the results and sign the same. The Managers, or someone designated by the Board, must deliver to the Commissioners of Election the poll list, the box containing the ballots and written statements of the results of the election.

The Managers at each precinct named in the Notice of Special Election are requested to delegate one of their number to secure the boxes and blanks for the election.

Boxes may be picked up at the Newberry County Court House between 9:00 o'clock and 12:00 o'clock on Saturday, November 15, 1969. The boxes may not be delivered to anyone other than a manager or clerk.
