To this, a large proportion, if not half of those present, dissented, and, claiming that gag law was practiced upon them; withdrew, and organ ized another meeting in the School house by the election of John Thompson chairman, and Wm. Brown and John Dixon secretaries.

They then unanimously elected the following delegates to the county nominating Convention: Abram Martin, Wm. Brown, A. B. Knowlton, John Thompson, Peter McFall, John Carmichael, J. Felder Myers, Jas. Adams Peter Walker and Edward Aiken.

The other meeting elected J. C. Moss r. K. Sasportas, Marshall Jones, Benj Byas, F. R. McKinlay, R. Turner, Isaac Jones, George Boliver, Sandy McMichael and R. Adams.

The People's Meeting.

THE people's meeting on Monday in opposition to the Ring was large and enthusiastic, and a greater number of colored people attended and took an interest than was expected for this politically enslaved Radical County. Col. A. D. Goodwin called the meeting to order, and upon motion Dr. T. A. Elliott was called to the chair, and Mr. Edward Felder requested to act as Secretary.

The first and chief business was the election of delegates to the Convention in Columbia, which after considerable pleasant skirmishing, in which nobody was hurt, resulted in the selection of W. T. Rives, W. A. Easterlin, F. W. Fairy, N. W. Sistrunk and Charles

After the adoption of the following resolutions, proposed by Mr. Samuel Dibble, the meeting adjourned:

RESOLVED, That a Provisional Executive Committee of five members be appointed by the chair, whose duty it shall be to adopt such measures as will place before the people of this county, a County Ticket, which will truly represent the honest voters of the County. and which will commend itself to the support of our good citizens, irrespective of parties.

RESOLVED, That said Committee shall be authorized, if it thinks proper so to do, to enter into correspondence with any other political association in 297 King St. 3 doors above wentworth, the County, and to act with such other associations, as they may deem advisable, in order to secure the object set forth in the first of these resolutions. S. Dibble, F. W. Fairy, Dr. B. H. Knotts, W. C. Wolfe and D. K. Norris were appointed on this Committee.
