

**Out and In.**  
The readers of the DEMOCRAT were informed two weeks ago that it was the purpose of Geo. Boliver to hold the office of clerk of the court, notwithstanding the verdict of the people, as declared in the late election, was overwhelmingly against him. Indeed he had so long been accustomed to rule here that he began to think the office, fixtures and profits were his by possession or some title which even the people could not annul. Hence to defend that right his last drop of blood and cent of money stood pledged. From this bold position assumed by Boliver and these defiant threats the people expected war to the knife, and Mr. Robinson, the clerk elect, fortified himself behind the best of surrities and the Governor's Commission before making the demand for the surrender of Boliver's stronghold. Preparations being completed, the demand was made on Saturday last for the unconditional surrender of office and contents. This was refused, or a compliance, evaded by a request for time to consider as to his best action. Nothing more was heard of the matter until on Monday morning, about 11 o'clock, Mr. Robinson with his chief clerk Mr. L. H. Wannamaker, and a few friends, finding the door opened, walked into the clerk's office, told J. G. Boliver and Dr. Malone, who were writing at their desks, that he had come to enter upon the duties of the office and that he had no use for them or need of their services. This was a bombshell in the camp, suddenly exploded and effective, and these gentlemen, taking in the situation, at once retreated, leaving Mr. Robinson master of the field. The work of making an inventory of every thing in the office was immediately begun and finally completed. During the day a notice was served on Mr. Geo. Boliver personally that Mr. Robinson had assumed the management of the office and was ready to give a receipt for the property. This was answered by a long, pointless and aimless protest which served only to excite a pleasant smile upon Mr. Robinson's features, because he knew Boliver was out and he was in. Every thing necessary to conduct the business of the office successfully was found except the seal which is locked up in the safe, the key of which Boliver refuses to surrender. This, however, does not materially matter as the general routine business can be performed without it. Mr. Robinson is now ready to wait upon our citizens who may have business in his office.

**Lynching.**  
Three young colored demons, two boys and a girl, aged respectively 15, 16 and 18, murdered Mrs. Ada Kennedy of Clarendon County on the 4th instant in a most brutal and horrible manner. A short while after Mr. Kennedy left home to secure the presence of his mother with his wife during a three days' visit to Charleston, these fiends appeared, demanded money and, being refused, brutally attacked Mrs. Kennedy with hoes and finally killed her by cleaving her skull with a hoe. One of the boys having been arrested, confessed the crime and told who engaged with him in committing the deed. The other boy and girl were forthwith arrested and by a vote of one hundred and fifty white men and fifty colored men and women, the young murderers were lynched and hung to a tree until they were dead.  
We are no advocates of extreme measures and certainly not of any mode of procedure which takes the life of a fellow being; but there are circumstances and occasions when the slow processes of the law do not meet the emergency and, to save society from panic, it becomes proper and necessary to deal summarily with offenders against its peace and safety. This seems to be a case, the

circumstances of which evidently justify the means employed. The same course would have been followed in any community of the North against the safety of which the same crime had been perpetrated. We desire to see our society free from even the apprehension, of such outrages, but this can never be while contemptible political leaders, such as we have, are suffered to poison the very elements of that society by exciting hatred and enmity between the races. Rid our country of these political vipers and we will hear of no more such crimes as the Clarendon and Branchville outrages.

**The Legislature.**  
This body continues at work and notwithstanding the purpose to adjourn before Christmas are cutting out new business every day according as each member thinks best for the interest of his county and State. Among the matters perfected and passed is the bill introduced by our Senator Gen. J. P. Izlar to fix the bond of County Commissioners at \$2,000 instead of \$500 as heretofore. We suppose the Commissioners lately elected will be required to give this bond. A special bill for certain counties, among which is Orangeburg, has passed to its second reading prohibiting the buying of seed cotton, except for manufacturing, in settlement between landlord and tenant and under process of law. It is likely now that this bill will become a law unless it be killed on passing its third reading which is unusual. A bill has been introduced to amend an act to prohibit persons from living together in adultery. We hope its provisions are sufficiently defined and severe to put a stop to the evil and that the bill will pass. The bill to utilize the labor of prisoners in jail was rejected. Two petitions: one from 5000 ladies of Charleston and one from 3000 ladies of Anderson, asking for a law prohibiting the sale of liquor in the State, were unrolled in the House and measured respectively 30 and 10 yards in length. These petitions were referred to a special committee of which our representative, Dr. Summers, is a member. The bill prohibiting the carrying of concealed weapons has occasion one or two hot discussions but has not yet assumed a form to allow an opinion of its final result.  
The appropriation and supply bills are being perfected rapidly and their provision indicate about the same tax levy as last year.

**Our Legislators.**  
Among the important matters introduced and likely to become enacted laws by our legislature are the following measure. A bill by Gen. Izlar creating a public guardian to all such minors as inherit property not under a will and constituting the Master as such officer; also a bill to make the office of Master general throughout the counties of the State; also a bill by Dr. Summers to limit the sale of intoxicating liquors including bitters or other drinks with alcohol as the base; also a bill to provide public scales at all points of trade where heavy products are weighed.  
These are all matters of general and local interest and look directly to the benefit of the State. Some of them we heartily endorse and hope they may be pushed successfully through. We are glad to see our members moving forward in such matters making a history for our county and a reputation for themselves.

**Judge Kershaw.**  
The General Assembly has again elected Gen. J. B. Kershaw to the position of circuit Judge by an almost unanimous vote. Judge Kershaw is one of the purest men in South Carolina and the General Assembly honors itself and the State by his election to this position.  
An occasional Washington correspondent of the Louisville Courier Journal writes thus: "It is not probable that Kellogg will be turned out. It is certain that he never should have been turned in. He was no more entitled to a seat in the Senate, as an original proposition, than Bob Ingersoll is entitled to a seat beside the angel Gabriel."
