KILLED IN THE PHILIPPINES.

Lieut. Max Wagner of South Carolina Falls in Luzon.

Gen. MacArthur, commanding in the Philippines, has reported to the Adjutant General at Washington that second Lieut. Max Wagner, Twenty-six Volunteer Infantry, was killed between Pavia and Santa Barbara, Pana, October 1.

Lieut. Wagner was born in St. James parish, Santee S. C., March 14, 1866, and entered the army as a private in the signal corps November 23, 1895. In June, 1898, he was commissioned second lieutenant in the volunteer signal corps and served in Cuba until mustered out in the following December. He was appointed second lieutenant in the Twenty-six volunteer infantry July 5, 1899, and accompanied that regiment from Pittsburg barracks, New York, to the Philippines in December last. He leaves a wife, who at last account was at West Medford, Mass.—Evening Post.

Lieut. Max Wagner is well known in Kingstree, having taught school here in his early manhood. A little over a year ago he paid a visit to friends here, remaining in town several days. Cut off in the flower of his youth, his death is a mournful example of the fruits of what Gen. Lawton called "this damnable war."
