"JUSTICE" CRITICIZES "CITIZEN" AND "A PRIVATE INTHE RANKS."

Thinks the Weekly Mail's Correspondents Should be Willing to Let the People Choose.

The articles of "Citizen" and "A Private in the Ranks," which names. appeared recently in The Weekly Mail seem to be attracting very little attention in this section: in fact, so far as we have been able to learn, they have produced no effect whatever except an effect opposite to the one intended by the authors.

These writers disclaim any ani mosity towards Senator Williams yet they make him the subject of their articles. They appear to be so much frightened at the mere thought that he may bite that they are trying to choke him off before he attempts to take hold. Their object, we suppose, is to try to create the impression that they are voicing the sentiments of the people of Williamsburg and thus persuade Dr. Williams to remain unannounced and leave the field open to their man.

Their insincerity in their protessions of esteem for Dr. Williams is apparent throughout their articles. "Private" after avowing his personal friendship, declares that the Senator is the child of designing politicians and could by no means win on his own merits. "Private" thus betrays his own insincerity and at the same time declares that that great body of voters who sent Williams to the senate term after term did not cast intelligent votes, but voted like sheep. And now he pretends to want to put these same mutton heads, as he calls them by inference, "to thinking."

This same writer says that the list as proposed by himself and "Citizen" should be boiled down to one and "put him out as the people's candidate." Who are to do the boiling? "Private" and "Citizen"? Who will then put out the "people's candidate?" "Private" and "Citizen?" Would such a one be the people's candi-

"Citizen" insinuates that Senator Williams thinks "he was created just to fill an office and that no one else can fill it but himself," while the "Private" indirectly declares that he is a "would-be political boss." Now, would it not be a better expression of the will of freemen for the people, not "Citizen" nor "Private" nor any one else, but for the people to say who shall be their candidate? Let every one of the eighteen proposed by these writers, let Dr. Williams, should he see fit, and let every one else who chooses come out for the office, and then let the people, not "Citizen" nor "Private" nor any other man Friday.
