After paying taxes examine your receipts and see if all of your property is covered, if not, see about it at once. By following the above suggestions complications and additional cost may be avoided. Registration Notice.

The office of the Supervisor of Registration will be opened on the 1st day of July and will remain open continuously every day, except Sundays, through the months of July and August for the purpose of the re-registering of any person who is qualified as follows: Who shall have been a resident of the State for two years, and of the county one year, and of the polling precinct in which the elector offers vote four months before the day of election, and shall have paid, six months before, any poll tax then due and payable, and who can both read and write any section of the constitution of 1895 submitted to him by the Supervisors of Registration, or who can show that he owns, and has paid all taxes collectable on during the present year, property in this State assessed at three hundred dollars or more.
