MADE QUICK GETAWAY.

Negro Manslayer Wanted Here Escaped from Sumter Jail.
Sumter, October 8:—Samuel Ridgeway, alias James Edwards, a negro, who was convicted at Kingstree recently of manslaughter and a sealed sentence left for him, was apprehended here to-day by Sergeant J M Barwick. This afternoon the prisoner was turned over to Jailer Owens till the Williamsburg authorities could be notified. But Ridgeway, alias Edwards, made a brilliant and "high gear" get-away from the jailer just as the jail yard gate was reached. As the prisoner was being taken handcuffed into the jail yard he suddenly wheeled and struck Jailer Owens a terrible blow in the face with the handcuffs and ran through Epperson's Hundred, a thickly settled negro district, making good his escape. Mr Owens tried to shoot at the escaping negro, but he was going so fast that nothing but an expert "wing shot" could touch him. Nothing more has been heard of him so far.—The State.
