LYNCHING IN PICKENS COUNTY

Negro Put to Death for Crime Against Farmer's Wife.

Greenville, July 1:- Charged with having attempted to ravish the wife of a farmer of Pickens county, and with shooting her twice in the back with a single barreled shotgun, as she ran through the field to her husband Brooks Gordon, a young negro, was taken from the custody of the Sheriff by a determined mob late Saturday afternoon and lynched.

According to reports from Easley Gordon attacked the woman as she was at work in the field at 10 o'clock Saturday. She broke loose from him and ran through the fields toward her husbund, who was about a half mile away.

The negro carried a single barreled shotgun and demanded to know of the woman if she intended to re port the matter to her husband She replied as she ran that she would tell her husband, and then the negro leveled the gun at her and fired The wound did not deter the woman in her purpose. Big Crowd Attended Campaign Meeting Saturday.

Andrews, July 1:-Your scribe attended the campaign meeting of the State candidates at Georgetown Saturday, June 29. The candidates for Railroad Commissioner spoke first, each presenting his claims for the office, especially old Mr Cansler of Tirzah. The candidates for Attorney General spoke next-Lyon, Earl, Evans and Peeples. Mr B B Evans accused the State of great graft in the old dispensary. The unopposed candidates were not present. Hon J E Ellerbe, Congressman from the Sixth district, was present but did not speak.

Gov Cole L Blease was the next speaker. He arose under a thunder of applause and handclaps. The Governor made his usual fiery speech and told his hearers that his opponent, Ira B Jones, voted with the negro Anderson, then in the Legislature from Georgetown, and a negro from Beaufort, five different times against the Jim Crow law, and said to the Georgetown people: "He tried by this act to make your wives and daughters ride in the same seat with the big buck negro men and negro wenches." He also said Mr Jones voted for a divorce law." Some one said he (Jones) wanted two wives. Gov Blease then referred to some of the people in Georgetown not being satisfied with his appointment of Mr J B Johnson and Mr Munnerlyn as Road Engineer and Mr J Walter Doar as Superintendent of Education, but he said if they did not like it to help themselves. He was glad to have a chance to ram it down their throats. He said his opponent signed as Speaker. He also got mad of Marshall unanimous, Mr Bryan out the State, according to Insurwith him (Blease) because he would started for the stage to make a ance Commissioner McMaster. GOV. THOS. R. MARSHALL OF IN-DIANA CHOSEN FOR VICE PRESIDENT.

Baltimore, July 3:-For President Governor Woodrow Wilson of

New Jersey. For Vice President - Governor Thos R Marshall of Indiana.

This was the ticket completed by the Democratic National Convention at 1:56 a. m. today.

The nomination of Governor Marshall, for Vice President, came as something of a surprise, for, when the night's balloting for Vice President began it seemed that the Bryan-Wilson contingent in the Convention had definitely settled upon Governor John E Burke, of North

There was not much of a fight however, and when two ballots disclosed Marshall easily in the lead, Governor Burke's name was withdrawn and Marshall was proclaimed the nominee by acclamation. minute later the Convention had adjourned sine die.

Governor Wilson was nominated at the afternoon session on the forty-sixth ballot, and his nomination, like that of Governor Marshall tonight, was quickly made unanimous. The best of feeling pervaded both

Mr Bryan had announced his intention of introducing a resolution in effect discharging the national committee from the conduct of the coming campaign and allow Governor Wilson to appoint his own campaign committee. He was dissuaded from this course, and, instead of making a move that might have the right. stirred up strife, he made a little speech which he termed his "valedictory" and in happy mood turned over the mantle of his former leadership as a presidential candidate to Governor Wilson.
