World's Fair Conference.

Fifty persons responded to the gubernatorial proclamation recently issued for the purpose of taking preliminary action towards having South Carolina properly represented at the World's Fair in Chicago.

Mr. J. A. Enlow of Charleston, warmly seconded the resolutions. South Carolina, he declared, has everything to give the State prestige, and has natural advantages which should be made known to the world.

The meeting then adjourned. The committee appointed under Gen. Butler's resolutions then held a brief session. Mr. Enlow was elected to act as chairman whenever Gen. Butler might be prevented from attending.

Yesterday, upon application, Chief Clerk Norton furnished some of them to a representative of The State.

are in progress, and that the dictator has determined to take the most rigorous measures to suppress the movement in opposition to his power.

So far, also, there has been no denial of the report that there has been more or less serious fighting, probably in the province of Rio Grande do Sul.

It is almost useless to add that explicit details as to the state of affairs in Brazil are anxiously awaited here, where so many financiers and merchants have important Brazilian interests.

WASHINGTON, Nov. 11.—The State Department has not heard anything from Minister Conger about the reported unsettled state of affairs in Brazil. It is settled on excellent authority, that reports from London of the secession of three of the provinces of Brazil, undoubtedly emanated in London to influence the stock exchange to the benefit of England, and that it is probably an endeavor on the part of England, to make the situation of affairs in Brazil appear as complicated as possible, hoping by such means to cripple the reciprocity treaty between the United States and Brazil.

LONDON, Nov. 11.—Authentic advice by way of Montevideo, state that the Brazilian province of Rio Grande do Sul has seceded entirely from the Brazilian republic, and the military in that province support the revolution.
