While the crowd was being talked to, Constable Rainey, with the negro securely bound, made his way unseen from the premises, and under cover of thick woods.brought the man safely to Taylor's just in time to catch No. 39, which was a few minutes late. He notified Sheriff Gilreath to meet him at the depot upon his arrival, which was done, and the negro was almost miraculously saved from the crowd bent on nothing less than lynching him and lodged safely in the county
